**TITLE: A RESOLUTION ESTABLISHING AN EMERGENCY IN THE TOWNSHIP OF LOWER**

**WHEREAS**, an emergency situation exists in the Township of Lower which effects the health, safety and welfare of Lower Township residents; and

**WHEREAS**, this emergency situation is due to the aftermath of the microburst and straight-line winds weather event storm of June 21, 2016, which caused major damage to many properties throughout the Township; and

**WHEREAS**, the vegetative debris still exists within the Township and is creating fire and safety hazards putting the public at further risk on a daily basis; and

**WHEREAS**, the Lower Township Council now deems it appropriate to take precautionary measures to prevent further destruction to the Township.

**NOW, THEREFORE, BE IT RESOLVED** that effective immediately, the Township Council of the Township of Lower hereby establishes an emergency situation in the Township of Lower and authorizes the Township Manager to take the necessary steps to resolve the situation.

Title: **AWARD OF CONTRACT(S) FOR REMOVAL OF STORM RELATED DEBRIS INCLUDING BRUSH, COMPOST, WOODCHIPS, ETC**

**WHEREAS**, Lower Township Council, by Resolution #2016-204, has established an emergency in the Township of Lower citing the safety, health and welfare of the residents being in danger due to the vegetative debris existing in the Township as a result of the microburst and straight-line winds weather event storm of June 21, 2016; and

**WHEREAS**, as per N.J.S.A.40A:11-6 Emergency Contracts, Any contract may be negotiated or awarded for a contracting unit without public advertising for bids when an emergency affecting the public health, safety or welfare requires the immediate delivery of goods or the performance of services; and

**WHEREAS**, because of the amount of the vegetative debris located throughout the Township and at the Management Area, and due to the current fire and safety hazards it has become necessary to award contracts on an emergency basis to expeditiously mitigate the hazardous condition; and
