In response to our Request for Proposals for Banking Services, we received three submittals: Sturdy Savings, Cape Savings and PNC.

The first, Sturdy Saving, is our current bank and their proposal contained the continuation of current services with no assessed charges, free checks and extended banking hours. In addition, they are offering an interest rate of .45% which should increase our interest revenue in the upcoming year by approximately \$30,000.

The second, Cape Savings offered the same services with no fees assigned and an interest rate of .45%.

The last, PNC offered .05% interest rate and an earnings credit rate of .19% to offset fees.

Based on the proposals, my recommendation is to remain with Sturdy Savings.





The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided by the public agency compliance officer setting for the provisions of this nondiscrimination clause.

The contractor or subcontractor, where applicable will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation or sex.

The contractor or subcontractor, where applicable, will send to each labor union or representative or workers with which it has a collective bargaining agreement or other contract or understanding, a notice, to be provided by the agency contracting officer, advising the labor union or workers' representative of the contractor's commitments under this act and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

AMERICANS WITH DISABILITIES ACT OF 1990

Equal Opportunity for Individuals with Disability

In the event that the contractor, its agents, servants, employees, or subcontractors violate or are alleged to have violated the Act during the performance of this contract, the contractor shall defend the owner in any action or administrative proceeding commenced pursuant to this Act. The contractor shall indemnify, protect, and save harmless the owner, its agents, servants, and employees from and against any and all suits, claims, losses, demands, or damages, of whatever kind or nature arising out of or claimed to arise out of the alleged violation. The contractor shall, at its own expense, appear, defend, and pay any and all charges for legal services and any and all costs and other expenses arising from such action or administrative proceeding or incurred in connection therewith. In any and all complaints brought pursuant to the owner's grievance procedure, the contractor agrees to abide by any decision of the owner which is rendered pursuant to said grievance procedure. If any action or administrative proceeding results in an award of damages against the owner, or if the owner incurs any expense to cure a violation of the ADA which has been brought pursuant to its grievance procedure, the contractor shall satisfy and discharge the same at its own expense.





The contractor or subcontractor agrees that a good faith effort shall include compliance with the following procedures:

- (A) If the contractor or subcontractor has a referral agreement or arrangement with a union for a construction trade, the contractor or subcontractor shall, within three business days of the contract award, seek assurances from the union that it will cooperate with the contractor or subcontractor as it fulfills its affirmative action obligations under this contract and in accordance with the rules promulgated by the Treasurer pursuant to N.J.S.A. 10:5-31, et. seq. as supplemented and amended from time to time and the Americans with Disabilities Act. If the contractor or subcontractor is unable to obtain said assurances from the construction trade union at least five business days prior to the commencement of construction work, the contractor or subcontractor agrees to attempt to hire or schedule minority and women workers directly, consistent with the applicable employment goal. If the contractor's or subcontractor's prior experience with a construction trade union, regardless of whether the union has provided said assurances, indicates a significant possibility that the trade union will not refer sufficient minority and women workers consistent with the applicable employment goal, the contractor or subcontractor agrees to be prepared to hire or schedule minority and women workers directly, consistent with the applicable employment goal, by complying with the hiring or scheduling procedures prescribed under (B) below; and the contractor or subcontractor further agrees to take said action immediately if it determines or is so notified by the Division that the union is not referring minority and women workers consistent with the applicable employment goal.
- (B) If the hiring or scheduling of a workforce consistent with the employment goal has not or cannot be achieved for each construction trade by adhering to the procedures of (A) above, or if the contractor does not have a referral agreement or arrangement with a union for a construction trade, the contractor or subcontractor agrees to take the following actions consistent with the applicable county employment goals:
  - (1) To notify the public agency compliance officer, the Division, and minority and women referral organizations listed by the Division pursuant to N.J.A.C. 17:27-5.3, of its workforce needs, and request referral of minority and women workers;
  - (2) To notify any minority and women workers who have been listed with it as awaiting available vacancies;
  - (3) Prior to commencement of work, to request that the local construction trade union refer minority and women workers to fill job openings, provided the contractor or subcontractor has a referral agreement or arrangement with a union for the construction trade;
  - (4) To leave standing requests for additional referral to minority and women workers with the local construction trade union, provided the contractor or subcontractor has a referral agreement or arrangement with a union for the construction trade, the State Training and Employment Service and other approved referral sources in the area until such time as the workforce is consistent with the employment goal;
  - (5) If it is necessary to lay off some of the workers in a given trade on the construction site, to assure, consistent with the applicable State and Federal statutes and court decisions, that sufficient minority and women employees remain on the site consistent with the employment goal; and to employ any minority and women workers so laid off by the contractor on any other construction site on which its workforce composition is not consistent with an employment goal established pursuant to rules implementing N.J.S.A. 10:5-31, et. seq.
  - (6) To adhere to the following procedure when minority and women workers apply or are referred to the contractor or subcontractor:
    - (i) If said individuals have never previously received any document or certification signifying a level of qualification lower than that required in order to perform the work of the construction trade, the contractor or subcontractor shall determine the qualifications of such individuals and if the contractor's or subcontractor's workforce in each construction trade is not consistent with the applicable employment goal, it shall hire or schedule those individuals who satisfy appropriate qualification standards. However, a contractor or subcontractor shall determine that the individual at least possesses the requisite skills, and experience recognized by a union, apprentice program or a referral agency, provided the referral agency is acceptable to the Division. If necessary, the contractor or subcontractor shall hire or schedule minority and women workers who qualify as trainees pursuant to these rules. All of the requirements, however, are limited by the provisions of (C) below.



- (ii). If the contractor's or subcontractor's workforce is consistent with the applicable employment goal, the name of any interested women or minority individual shall be maintained on a waiting list for the first consideration, in the event the contractor's or subcontractor's workforce is no longer consistent with the applicable employment goal.
- (iii). If, for any reason, said contractor or subcontractor determines that a minority individual or a woman is not qualified or if the individual qualifies as an advanced trainee or apprentice, the contractor or subcontractor shall inform the individual in writing of the reasons for the determination, maintain a copy of the determination in its files, and send a copy to the public agency compliance officer and to the Division.
- (7) To keep a complete and accurate record of all requests made for the referral of workers in any trade covered by the contract, on forms made available by the Division and submitted promptly to the Division upon request.
- (C). The contractor or subcontractor agrees that nothing contained in (B) above shall preclude the contractor or subcontractor from complying with the union hiring hall or apprenticeship policies in any applicable collective bargaining agreement or union hiring hall arrangement, and, where required by custom or agreement, it shall send journeymen and trainees to the union for referral, or to the apprenticeship program for admission, pursuant to such agreement or arrangement. However, where the practices of a union or apprenticeship program will result in the exclusion of minorities and women or the failure to refer minorities and women consistent with the county employment goal, the contractor or subcontractor shall consider for employment persons referred pursuant to (B) above without regard to such agreement or arrangement; provided further, however, that the contractor or subcontractor shall not be required to employ women and minority advanced trainees and trainees in numbers which result in the employment of advanced trainees and trainees as a percentage of the total workforce for the construction trade, which percentage significantly exceeds the apprentice to journey worker ratio specified in the applicable collective bargaining agreement, or in the absence of a collective bargaining agreement, exceeds the ratio established by practice in the area for said construction trade. Also, the contractor or subcontractor agrees that in implementing the procedures of (B) above it shall, where applicable, employ minority and women workers residing within the geographical jurisdiction of the union. **WHEREAS**, on July 24, 2014, the Division of Local Government Services issued Local Finance Notice 2014-9 (i) alerting local governments to the SEC Initiative, (ii) strongly recommending that local governments examine their continuing disclosure contractual obligations and past official statements in order to determine if it is advisable for an issuer to participate in the SEC Initiative and (iii) cautioning local governments that fail to complete a disclosure assessment in connection with the SEC Initiative will likely have difficulty accessing capital markets, difficulty in receiving timely approvals of the Local Finance Board or Director of the Division of Local Government Services, as applicable, and decreased scores on the future "Best Practices Questionnaires"; and

**WHEREAS**, the Issuer desires to conduct a disclosure audit which will (i) summarize the results of the Issuer's prior compliance with its secondary market disclosure obligations and (ii) compare those results to the statements made by the Issuer in its official statements regarding past compliance (the "Disclosure Audit"); and

**WHEREAS**, the Issuer further desires to retain the services of disclosure specialist to conduct the Disclosure Audit; and

**WHEREAS**, based on the results of the Disclosure Audit, and weighing heavily the known, non-monetary penalties that may come through the Issuer's participation in the SEC Initiative versus the unknown, and, by all accounts, hefty monetary and non-monetary penalties the SEC has threatened on issuers that do not self-report, the Issuer further desires to delegate to the Chief Financial Officer, in consultation with the Issuer's general counsel, bond counsel, auditor and other finance professionals, the power to prepare and submit all documentation required to enter the Issuer's Bond issues into the SEC Initiative, as necessary;

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LOWER, AS FOLLOWS:**

**Section 1.** The Issuer hereby authorizes completion of the Disclosure Audit.







Hatch Mott MacDonald (HMM) is pleased to submit this proposal to provide professional engineering & environmental services for the above referenced project. It is HMM's understanding that the Township wants to upgrade their existing beach access paths with a gravel base. The Township must also re-apply for a Coastal Permit for Beach Maintenance since its last permit has expired.

The Township has identified thirty (30) existing beach paths located between Douglass / Canal Park and Ocean Avenue in the Villas that are in need of improvement. These existing paths consist of varied widths with some having steep vertical slopes and others impeded by drifting sand. Winter winds from the bay annually impact these beach paths and existing dune grades make some of the longtime maintained paths identified in the Township's Beach Maintenance permit difficult to use at the street level due to steep slopes, rutting and narrowing from overgrowth of vegetation.

It is our understanding that the Township desires to stop using the composite roll-outs at many of these locations as conditions have caused them to be less practicable. These temporary walkway structures tend to get slippery as sand accumulates from pedestrian traffic. This condition when combined with steep slopes and localized erosion at the foot of the path negatively impacts the safe use of the beach paths.

To improve the presently limited pedestrian access conditions at the existing beach paths the Township proposes to widen the paths to a consistent width and demarcate the beach paths with post and rail fence. It is our understanding that the Township wants to make a conscious effort to maintain these access paths in a responsible manner. Minor grading and widening to a uniform width (8' or less) and demarcation using post & rail fence will accomplish these goals. In our discussions with NJDEP the agency recognizes that post and rail fencing is commonly used in many Atlantic Ocean beach communities. However, only the use of snow fence is covered under the Township's Beach Maintenance General Permit therefore a CAFRA Individual Permit must be applied for to make the above improvements.



The proposed path re-construction activities will not negatively impact the form or function of the existing dunes. Whereas using snow fence on both sides of the paths, as tried in the past, has only exacerbated the local buildup of sand on the pathways. The post and rail fence will allow the sand to pass over the path and settle in the vegetated dune, where it should, leaving the pathways in a more stable state over the winter months thus minimizing spring maintenance activities. Discussions with the NJDEP indicate that the agency will work to expedite their permit review to afford the Township time to make the beach path improvements in time for the summer season.

As of November 5 2015, the New Jersey Department of Environmental Protection (NJDEP) will not approve authorization under a general permit to any municipality that does not have a Department-approved Municipal Public Access Plan in accordance with N.J.A.C.7:7-16.9(c) through (m). Since the Township does not have a Department-approved Municipal Public Access Plan, the Township will be required to secure a CAFRA individual permit for beach maintenance activities.

This proposal includes the preparation of the necessary engineering plans and CAFRA Individual permit application by HMM for approval by the NJDEP.

#### **Task 1      CAFRA Application Preparation & Submission**

Under the NJDEP Coastal Permit Program Rules N.J.A.C. 7:7-2.2, a CAFRA permit shall be required for development activities located on a beach or dune. These activities include beach maintenance and the upgrades to the existing beach access paths. The following outlines our proposed scope of services for work included under Task 1 for the project:

- Research existing site conditions to obtain necessary information in support of the preparation of a CAFRA permit application to the NJDEP;
- Assemble documents and prepare materials required for the preparation of a Coastal Zone Management (CZM) rules Compliance Statement and CAFRA application submission.
- Preliminary review indicates that potential Endangered or Threatened Wildlife or Plant Species on or abutting the project site. Therefore an Endangered or Threatened Wildlife or Plant Species Habitat Impact Assessment will be prepared in accordance with N.J.A.C. 7:7- 11.2 to demonstrate that identified species habitat would not be adversely affected by the proposed project;
- Request a certified Adjoining Property Owners list from the municipality and prepare public notifications to governmental agencies, newspaper and adjacent property owners as required;
- Communication, coordination and review of information to be submitted to the NJDEP with the Client;



- Monitor and respond to NJDEP information requests to deem application complete for final review; and
- Review of permit conditions relative to potential impacts on the Client/Project.

We propose to complete the scope of work outlined above (**Task 1**) for the lump sum amount of \$11,800. This lump sum cost is based on the following:

1. The lump sum cost, as outlined above, is for the initial submittal of the project plans to the NJDEP Land Use Regulation Program, and includes all work required to fulfill general CAFRA submittal requirements. Should the NJDEP request additional information and/or documents that fall beyond the scope of the original submission, the work effort required to respond to these requests will be considered additional work outside our original scope of services.
2. The Owner and/or Client will pay all of the permit application fees required for the project.
3. The scope of services outlined above for Task 1 has been prepared based upon the current Coastal Zone Management Rules under N.J.A.C. 7:7, last amended July 6, 2015. While we don't anticipate that there will be any regulatory changes that would impact the project during the permitting process, it may be necessary to adjust our scope of work and lump sum fee should major regulatory changes occur.
4. Within 20 working days of receipt of a CAFRA application, the NJDEP is required to take one of the following actions:
  - i. *Assign an agency project number, accept the application, and issue notification to the applicant that the application is complete for public hearing or for a public comment period and a public hearing or public comment period shall be scheduled within 15 days;*
  - ii. *Assign an agency project number, accept the application and issue notification to the applicant that additional information is required to correct deficiencies; or*
  - iii. *Return the application, explaining why it is unacceptable for filing, and return the filing fee upon notification that the applicant does not intend to reapply.*
5. It is HMM's goal in all CAFRA applications to provide all necessary information in order for the NJDEP to assign an agency project number, accept the application and notify the applicant that the application is complete for public hearing or public comment period based on our initial submittal application package.

The NJDEP's review of CAFRA projects is based on rules promulgated for the entire CAFRA zone. Since interpretations of the rules may vary, depending on the site location, environmental sensitivity, nature of the development, and other factors such as public comments, it is not possible to predict with certainty that a



particular NJDEP reviewer will deem the application package “complete for final review” based on the initial submittal.

As such our lump sum cost under this Task does not include the cost for any additional requests from regulatory and governmental agencies not previously specified or identified, or subsequent revisions to the CAFRA application based on 1) project revisions or modifications; 2) issues resulting from public comment; or 3) responses to permit conditions. Any work associated with the above additional requests, revisions or modifications will be considered outside our scope of work.

### **Task 2 Topographic Survey & Beach Path Design**

HMM will provide the following services under Task 2:

- Establish survey control for the site. The Horizontal Datum will be NAD83 and the Vertical Datum will be NAVD88;
- Perform limited topographic survey of the pre-selected existing beach access paths for the purposes of establishing existing alignments and grades;
- Provide a cross-sectional typical detail of the proposed beach paths; and
- Prepare a plan detailing the proposed centerlines of beach access paths;

We propose to complete the scope of work outlined above (**Task 2**) for the lump sum amount of **\$7,375**. This lump sum cost is based on installing new gravel pathways in the existing beach path alignments. This proposal does not include evaluating alternative beach path alignments which, while improving (minimizing) the longitudinal slope of existing beach paths, would involve the modification of dunes and dune planting areas outside of the current alignments.

### **Task 3 Reimbursable Services and Direct Expenses**

The scope of work under this section includes the following services and direct expenses not specifically identified in Tasks 1 and 2.

\_\_\_\_\_ (1) Matters Required by Law to be Confidential: Any matter which, by express provision of Federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act.

\_\_\_\_\_ (2) Matters Where the Release of Information Would Impair the Right to Receive Funds: Any matter in which the release of information would impair a right to receive funds from the Government of the United States.

\_\_\_\_\_ (3) Matters Involving Individual Privacy: Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to information, relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly.

  X   (4) Matters Relating to Collective Bargaining Agreement: Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body. **CONTRACT NEGOTIATIONS**

\_\_\_\_\_ (5) Matters Relating to the Purchase, Lease or Acquisition of Real Property or the Investment of Public Funds: Any matter involving the purchase, lease or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed.

\_\_\_\_\_ (6) Matters relating to Public Safety and Property: Any tactics and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection. Any investigations of violations of possible violations of the law.

  X   (7) Matters Relating to Litigation, Negotiations and the Attorney-Client Privilege: any pending or anticipated litigation or contract negotiation in which the public body is, or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.

**LITIGATION/POSSIBLE LITIGATION UPDATES**

\_\_\_\_\_ (8) Matters Relating to the Employment Relationship: Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting.


